- 6. Elect Chair / Vice Chair action Commissioner Doyle made a motion to appoint Commissioner Shellhamer the 2022 chair. Commissioner Scopa seconded.  - **Meetings** The county chief's meeting was cancelled.
 - AFG Grant The grant was extended and is now due on January 21st.
 - Bunker Gear Several of the firefighters came to the meeting to show off the new gear that we received last week. The gear was purchased with the help of a grant from the Marathon Refinery.
 - Tribe Chief Weiss thanked the Tribe for committing funds to our District for 2022. He also gave them a shout out for all their help during the snow. Not only did they plow our driveway during all the snow they also provided food when there was a large power outage in Shelter Bay. During the power outage, a warming center was opened up at Shelter Bay's community center for those that needed to get warm. The CERTs staffed the center and the tribe provided food for all. CERTs, DEM and the tribe all came together.
 - **Snow** Our new four-wheel drive worked really well during the snow. The engine was chained but the ambulance did not need to be chained.
 - Sewer System The sewer system was backing up into Station one. Chief Weiss called Johnny's Septic and they came and pumped the tanks and discovered the issue. It should be fixed sometime next week.
- 12. **Medical Officer Report no action** Assistant Chief Jurdi was on vacation. Chief Weiss and Assistant Chief Jurdi were able to complete the quality management of all the reports for 2021. For the month of December there were 28 transports.
- 13. **Training Officer Report no action** No report. Lieutenant Jenkins was not available to attend the meeting. All in person training is cancelled for now.
