MEETING MINUTES June 9th, 2022

- 1. Call to order Chairman Shellhamer called the meeting to order at 9:00 a.m.
- 2. **Flag Salute** Chairman Shellhamer lead those present in the Pledge of Allegiance.
- Consent Agenda action Commissioner Shellhamer moved to approve the agenda. Commissioner Doyle seconded. Commissioner Shellhamer called for any more discussion and then for a vote. The motion was unanimously approved.
- 4. Attendees no action Present were Commissioner Bruce Shellhamer, Commissioner John Doyle, Commissioner Jeremy (JJ) Wilbur, Chief Wood Weiss, Assistant Chief Jamie Jurdi, Captain Gary Ladd, District Secretary Tracy Berg, Chief Administrative Assistant Chris Weiss, Lieutenant Drew Jenkins, Firefighter Andrew Schram, Firefighter Bobbie Scopa and Captain Ted Taylor. Guests present were Bill Reynolds from the La Conner Weekly News and Karen Miltenberger from Nicholson & Associates.
- 5. Public Comment N/A
- 6. **Approval of Minutes action –** District Secretary Berg presented the minutes from the May 12th, 2022 special meeting. Commissioner Doyle made a motion to approve the meeting minutes. Commissioner Shellhamer seconded. Commissioner Shellhamer called for any more discussion and then for a vote. The motion passed unanimously.
- 7. **Financial and Administrative Reports action –** District Secretary Berg presented the following checks and check registers for approval by the Board:
 - Checks and Check Register dated 6/1/2022 in the amount of \$74,258.54.
 This included payroll check #s 10952-10962, DD1029-DD1054 and EFTPS in the amount of \$57,251.38 and check #s 10963-10984 in the amount of \$17,594.81 for accounts payable.
 - Checks and Check Register dated 6/9/2022 in the amount of \$12,665.06 for accounts payable. This included check #s 10985-10998.
 - Transmittal voucher dated 6/1/2022 in the amount of \$80,000.00.
 - Commissioner Shellhamer moved to approve the checks and check registers as presented. Commissioner Doyle seconded. Chairman Shellhamer called for any more discussion and then for a vote. The motion was unanimously approved.

- District Secretary Berg previously emailed the financial reports ending 5/31/2022.
- 8. **Insurance no action** Karen Miltenberger from Nicholson & Associates gave a presentation on the quote they sent over a couple of weeks ago and also other types of insurance her company offers. They also have a Washington State Risk Management Group that offers a discounted rate for certain trainings. They do have annual meetings. She offered to have a workshop to go over the details.
- 9. **Station Improvements no action** Commissioner Doyle sent out an estimate that he received from Coach Corral. He has been trying to get two other estimates but the other companies have not responded. Commissioner Doyle did meet with Coach Corral to go over the site and answer any questions they had. He is also hoping the tribe can help us move forward with our project. The time frame to get the unit through Coach Corral is 3 months.
- 10. Chief Report no action -
 - COVID 19 Report Chief Weiss gave an update on Covid 19 in the county and the reservation.
 - Statistical Report Chief Weiss gave an update on call statistics.
 - Meetings Chief Weiss attended the Chief's meeting. Dispatch is close to 50% staffing right now which is very concerning. Chief Weiss also attended the Chief's Conference and the Commissioner's Conference. The main topics were policies and procedures, firefighter evaluations, exit interviews and physicals. He would like to form a committee to go over our policies and update them. He would like for himself, Secretary Berg, Commissioner Doyle, Captain Ladd and Assistant Chief Jurdi on the committee.
 - Physicals Chief Weiss has asked Commissioner Wilbur to see if the clinic could help us out with employment physicals when we hire new shifters.
 - **Tactical Vests** Chief Weiss has been watching some of the things happening around the country and he is thinking we need to start looking into getting a kill kit for protection for our members. Lieutenant Jenkins is helping him look into pricing.
 - Community Paramedicine Program Chief Weiss is still working on getting
 this program going. He would like to have two members full time working four
 days a week, ten hours a day. The program would be similar the ones at the
 fire departments in San Juan and Tulalip Bay. They are still in the beginning
 stages figuring out the program. Once they have completed the homework, it
 will be brought to the Tribal Senate to see if they will help with funds to have
 the program move forward.
 - Forcible Entry Door Prop Chief Weiss and Captain Ferrell have been researching a forcible entry door prop. They cost about \$8,000.00. There are neighboring districts that are also interested in using it.
- 11. **Medical Officer Report no action** Captain Drew Ferrell was unable to attend the meeting.
- 12. **Training Officer Report no action** Lieutenant Jenkins gave an update on upcoming training. He is looking into having an active shooter drill. The academy is finished. Two of the recruits have moved into shifter positions. He would like to see the trainees have a couple of 24 hour shifts before moving into shifter

shifts.

- 13. **Specialty Training Report no action** Captain Olbu gave an update on specialty training that is coming up.
- 14. Assistant Chief Report no action
 - All four engines are getting their pump testing done today.
 - They had their last demo for Jaws of Life last night. They have narrowed it down to 2 different models.
 - A hose cleaner is under \$600. Chief Weiss said we could just order.
 - The DNR tools, equipment and supplies are starting to come in.
 - Six of our firefighters did the red card training last weekend. They will be finished up this weekend.
 - Chief Weiss and Assistant Chief Jurdi decided to take the tender off the wildland response list. They are possibly thinking of adding an ambulance though.
- 15. **Morning District 13 no action –**Captain Ladd gave an update on the Good Morning District 13 program. He has interviews with 3 potential new people this week.
- 16. DEM Report no action Captain Taylor gave his DEM report. They had the preparedness fair last weekend but the weather was very rainy. There is a marina fire drill on June 22nd. He also presented a tsunami inundated map for Skagit County.
- 17. **Executive Session** Adjourned at 10:24 a.m. for 30 minutes for *RCW* 42.30.110 (1) (g) to evaluate the qualifications of an applicant for public employment or to review the performance of a public employee. Reconvened at 10:54 p.m. No action taken.
